Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

4. Pre-bid meeting shall be held at Miklajung Rural Municipality at 29th Baisakh, 2076.
5. Sealed or electronic bids must be submitted to the office Miklajung Rural Municipality by hand or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Hrs 9th Jestha, 2076. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs 9th Jestha, 2076 at the office of Miklajung Rural Municipality. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 66,000.00, which shall be valid for 30 days beyond the validity period of the bid 9th Ashoj, 2076.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The estimated cost is Nrs. 22,16,185.63 (Including VAT)
