4. Pre-bid meeting shall be held at 29th Baisakh at 5:00 pm.
5. Sealed or electronic bids must be submitted to the office Miklajung Rural Municipality, Rabi by hand or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs on 10th Jestha, 2076. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 10th Jestha, 2076 at the office of Miklajung Rural Municipality, Rabi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs 3,60,000.00 which shall be valid for 30 days beyond the validity period of the bid 10th Ashoj, 2076.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
